| Why? | Credit unions choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. | <p>How does BluCurrent protect my personal information?</p> | <p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. Additionally, we restrict access to information about you to those employees who provide products and services to you.</p> |
| <p>How does BluCurrent collect my personal information?</p> | <p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> ▪ open an account or deposit money ▪ apply for a loan or use your credit or debit card ▪ make a wire transfer <p>We also collect your personal information from others, such as credit bureaus or other companies.</p> |
| <p>Why can't I limit all sharing?</p> | <p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> ▪ sharing for affiliates' everyday business purposes—information about your creditworthiness ▪ affiliates from using your information to market to you ▪ sharing for nonaffiliates to market to you |

Definitions

| <p>Affiliates</p> | <p>Companies related by common ownership or control. They can be financial and nonfinancial companies. <i>BluCurrent's affiliates include businesses such as: the credit union data technology CUSO and mortgage services.</i></p> |
| <p>Nonaffiliates</p> | <p>Companies not related by common ownership or control. They can be financial and nonfinancial companies. <i>BluCurrent does not share with nonaffiliates so they can market to you. The credit union only makes disclosures to nonaffiliated third parties as permitted by law necessary to effect, administer or enforce a transaction such as: statement mailers, check printers, IRA Service Suppliers, ATM usage, etc.</i></p> |
| <p>Joint marketing</p> | <p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <i>BluCurrent's joint marketing partners include businesses such as: insurance, checking rewards, etc.</i></p> |
